Leadership Development: Community partners and business/elected leaders serve as important role models - they teach Ambassadors about resume building, professionalism, financial planning, and expose them to multiple career opportunities and to the skills needed to advance in their field of interest. 3. Personal Development: YA maintains a high retention rate (85%) because it offers a "blended" learning opportunity. Writing, documentary development, fine art, and photography are used as meaningful tools for promoting the self-understanding and self-worth that help Ambassadors overcome individual challenges and personal boundaries to success, and contribute to positive outcomes. Work for Hire: Youth Ambassadors are hired to explore themselves and their communities and then educate our extended community on the issues affecting youth today. No one knows better than the youth themselves what is really happening on the streets, in the schools, and in their homes. Educators, policy makers, and community leaders are then given a first hand account of the issues that need addressing. Through the publication of their writings, the development of documentaries, and photography, the youth present life as it is today. The "paycheck" is also the carrot that brings and keeps our youth to the table. While we have them "at the table" our students are taught vital soft-job skills that help prepare them for success in entry-level jobs in their communities. All ambassadors learn the importance of a handshake, eye contact, appropriate communication skills, interview skills, time management, resume building, and appropriate behavior in the workplace. Program Progress: In September 2014 we added an important education component to our program. We currently have a full time school counselor and academic tutor on staff. As a prerequisite to being hired we require our Ambassadors present a record of their school attendance every two weeks and a record of their class grades every semester. In addition, we give a "perfect attendance" cash incentive every bi-weekly. Since this incentive was established, our Ambassadors' perfect attendance rate has jumped above 50%. We also now have an official on-going record of everyone's school attendance. This record will make improvement of school attendance easier to track. In 2014 we employed 50 Kansas City, Missouri students for our spring, summer, and fall sessions. In addition we employed 27 Kansas City, Kansas students for our summer session in Kansas. Currently we are prepared to hire 75 students this summer in Missouri and 45 students in Kansas. Youth Ambassadors has established a partnership with DeLaSalle Education Center in Kansas City. Currently their school is unoccupied during the summer months with the exception of a few administrative personnel. Starting June 2015 all of our programming on the Missouri side will be held at DeLaSalle. This includes our year-round program on Saturdays during the school year. We will also be providing an afterschool program at DeLaSalle beginning in the Fall of 2015. We have begun talks with Hogan High School. They are very interested in partnering with us to provide our Youth Ambassadors program at their school beginning the summer of 2016. Beginning the Fall of 2015 plans are being made to provide a one or two day a week afterschool Youth Ambassadors program at their school. We have begun talks with Cristo Rey Kansas City High School. They are very interested in partnering with us to provide our Youth Ambassadors program at their school beginning the summer of 2016. Beginning the Fall of 2015 plans are being made to provide a one or two day a week afterschool mini Youth Ambassadors program at their school. We had our first of many Career Days on Feb. 28th. During this day, 17 professionals representing different careers presented to our Ambassadors and then were available for an individualized question and answer time and possible continued mentorship. Last year we piloted a summer school, mini YA program for the month of June at Gordon Parks Elementary School. For this program, Youth Ambassadors from the Ivanhoe YA program taught K-2 grade students a mini YA program that included writing, poetry, art, public speaking, personal reflection, and anger management. We plan to repeat our program this summer and include third grade to our curriculum. We are developing a model with the UMKC Social Work Department to provide a year round social worker to join our staff. This is an important addition for our program as many of our students deal with trauma; grief and loss, violence, adoption and the foster care system. UMKC Dr. Elaine Spencer-Carver will be using our book I'm Not No One in her class on Family and Community Violence beginning this fall. In addition, four MSW students in their final year of study at UMKC will be doing their practicum at Youth Ambassador sights. The Hall Family Foundation connected us with the Youth Volunteer Corps of Greater Kansas City in hopes that Youth Ambassadors could help them access urban core youth. Fall of 2015 we plan to join forces once a month to bring youth from different parts of our city together through volunteerism. In addition, we are fortunate to be the recipient of endless professional hours donated to us by VML in the form of book layout and design. By the end of the summer we plan to release our second book designed by them, "Children's Stories Not for Children." This powerful book will be used to educate our community on the unspoken plight of many of our youth today.
