Support Groups: During our first full year of services, support and networking groups grew throughout 2012. There were 198 group sessions held with 819 visits to the groups. Groups provide support and community to children, teens, and adults who have been impacted by cancer, including general groups and groups related to specific cancers, groups for family and friends of people with cancer, and bereavement groups.

Educational Programs and Healthy Lifestyle Programs: Educational programs include our nationally distributed Frankly Speaking About Cancer series facilitated by leading local health care providers. Healthy lifestyle programs include cooking, art, exercise, and meditation classes. There were 84 classes and workshops offered during 2012 with 540 people impacted by cancer participating.

Social Activities: Social activities such as community pot-lucks, Fall Festival, and comedy and game nights were held throughout the year. There were 38 events held with 353 visits to the events which provided much needed community and networking at a time that can be very difficult for individuals and families experiencing cancer.
