IN 2010, THE ORGANIZATION ACHIEVED 5,704 SPAY/NEUTER SURGERIES FOR THE YEAR. THE GOAL OF THE SERVICE IS TO REDUCE THE NUMBER OF UNWANTED PETS IN THE METRO AREA. A TOTAL OF 1,766 HOMELESS ANIMALS FOUND PERMANENT HOMES EITHER THROUGH DIRECT ADOPTION OR THROUGH TRANSFER TO OTHER NO KILL PROGRAMS. 14,639 CLIENTS (LOW-INCOME PET OWNERS) WERE SERVED IN 2010 AND 21,262 ANIMALS WERE SEEN IN THE PREVENTATIVE CLINIC. IN JANUARY 2009, THE ORGANIZATION BEGAN A PARTNERSHIP, CALLED THE RAY OF HOPE, WITH THE KCK ANIMAL CONTROL TO REDUCE THE EUTHANASIA RATE IN THE CITY SHELTER.
