During 2011, over 3,300 cancer patients received much needed support to relieve distress and improve their quality of life. Programs and services are offered to any person through every stage of their cancer experience.

Community Education Program provides education to the general public on prevention, early detection, and ways to reduce a person's risk of cancer. Volunteer Program recruits, trains, and manages the hundreds of volunteers that help offer support, comfort, and care to the organization's clients.
