In serving these areas the program focuses on the safety, wellness, and permanency of children affected by child abuse and neglect. Children that are in the care and custody of the Children's Division are ages 0-21 and all ethnicities. The services are provided in the parental home, relative home, kinship home, foster home, adoptive home, residential setting and group setting. Community resources offered to families to remedy the effects of abuse and neglect and prevent abuse and neglect are: therapy, parent education, substance abuse treatment, crisis intervention, educational resources for children, and behavioral intervention options.

Nurse Case Management- Provided nurse case management to children who are in Children's Division custody in Jackson County. Primarily monitor to ensure both medical and mental health needs are met while in custody.
