Children who are in Kindergarten through 4th grade are eligible for the program, and preference is given to students living in the Historic

4b (Code:) (Expenses \$ 89,901. including grants of \$) (Revenue \$) Character in Training - Character In Training serves 30 community youth, is the second-tier in our developmental youth programming, and is a program designed to assist students in the development of their personal character and Citizenship through a variety of interactive lessons on Faith, Family, Flag, Finances and Future. Students also participate in service projects, singing and dance activities, journaling, games, skits, dramatic readings and special events/field trips. Children who are in 4th-6th grades are eligible for the program.

4c (Code:) (Expenses \$ 134,851. including grants of \$) (Revenue \$) Leaders in Training - The Leaders In Training (L.I.T.) program serves 30 community youth, is the third-tier in our developmental youth programming and is comprehensive in nature. Leaders In Training is committed to giving youth the assets needed to reach their full potential. To ensure that this occurs, The Hope Center is committed to providing: one L.I.T. coordinator for every 15 kids admitted into L.I.T., a team of trained, committed volunteers to invest in the youth, a holistic program that develops the kids in seven areas, a combination of classroom and experiential learning. Students who are 7th grade and older are eligible for L.I.T.
